# Minutes 8-31-22

#### 5. Local Reportable Incidents -

- Jacob City/Soldier Canyon flooding events
  - i. Town of Stockton has been in a water crisis. On July 9<sup>th</sup> they declared to Tooele County for assistance in restoration and recovery from the effects of the fire. The agreement expired in the 1<sup>st</sup> week of August. They are attempting to restore their generator so they can resume well function. The town may need to raise water rates. Two alluvial fans in the area were significantly burned. The rain events in Aug caused flooding in those areas. The county will be the sponsoring agent for the NRCS grant.
- b. Boil Water Order for Stockton Residents
  - i. An order was issued for the town. They are sampling daily. The water filtration system needs work, and they are working on securing funding for that. They have not had any bad samples to date.
- c. I-80 Incident 2 semi-trucks fire
  - i. One semi was carrying grain and one was carrying Tesla parts. Grantsville, Wendover and NTFD responded. The road was partially shut down. The front semi driver was able to rescue the back semi driver. NTFD response boundary goes all the way to the 31-mile marker. Because their boundary goes so far west those agencies along the corridor including Wendover will be paged as well.
- d. Skretting Industries Oil Fire -

- i. Fish Plant had a fire. It is east of the North Point Medical Complex. The fire started in a garbage can that combusted.

- f. McKenzie Jones- Red Cross- They have been helping with the Kentucky Floods. They have done some damage assessments in Moab and provided cleaning kits with the help of The Church of Jesus Christ of Latter Day Saints.
