## **Minutes 7-27-22**

### **5. Local Reportable Incidents –**

- a. Jacob City Fire – 2:30 PM on July 9<sup>th</sup> the fire started by an individual. 30-35 mph winds were in the area. The fire spread rapidly. Type 3 team responded. There were evacuations of 8 homes in Soldier Canyon. Ophir was put on standby. An evacuation center was set up in Stockton just for 4 hours as no one needed it. Eventually a type 2 team responded. Total 4185 acres burned. It is now 100% contained. A very successful community meeting was held for post wildfire. The canyon will be prone to flash flooding. The county is meeting to discuss managing restoration of area and reconstruction of watershed area.
  - i. Bryan Slade- The State Division of Drinking Water took over event early on. Sole supply of water is coming from emergency well for the town of Stockton. TCHD has been taking water samples and they are coming back ok. This is a temporary situation. They will need to make some improvements to their current water system.

### **6. Update: Country Fan Fest**

- a. July 27-30. Inflow for campers began today. They will have an onsite emergency operations center. The weather service will be onsite as well for hour by hour forecast both for heat and microburst winds. Avoid travel through the Deseret Peak area. The county has mass notification capabilities if needed. 13,000=16,000 per day are expected. UDEM have a command post set up on site.

### **7. Update: Tooele County Drought Conditions**

- a. 2/3 of Tooele County in D3 drought. 1/4 in a D4 drought. We are at high risk for serious problems with rain with soil absorption.
